## **League matches.**

## 2. Help! What do I do now?

The second in a series of features in which a point of law will be explained.

### ***My opponent is about to make an error. What do I do now?***

Do you stop him or sit back and do nothing?

Interrupting your opponent is called *Forestalling* and there are laws covering each situation so although a generous player may be inclined to being helpful, the laws state that you should not. However, it is not that simple.

Croquet is a game in which both players are referees and there are occasions when, acting as a referee, you SHOULD forestall your opponent and occasions when you SHOULD NOT.

To simplify the matter, you *should not* forestall your opponent if he is about to make an error but you *should* forestall him if he *has* made an error or is about to play a questionable shot which may produce a fault and should therefore be watched.

### **How to forestall.**

This may seem obvious but it is important not to forestall when the opponent is actually playing the shot but immediately afterwards. If you interrupted his shot, he would be entitled to replay it (and may not make a fault the second time around).

[Law 23d]

**You must not forestall** if your opponent is:

About to run a wrong hoop;

About to play a wrong ball;

About to take croquet from a dead ball.

[Law 23b] BUT.....

**You must forestall** immediately if your opponent:

*has* done any of the above;

is playing when not entitled to do so;

has committed a fault;

is about to play a hampered shot (where there is insufficient room for a normal mallet swing);

is about to attempt to run a hoop from close quarters (because he may “double tap”);

if he wrongly thinks his turn has ended;

if a clip is misplaced (which may give false information about the state of the game);

a boundary is displaced. You may be puzzled by this one because at The Bear, we have white lines to show our boundary but some clubs have string which can be deflected.

[Law 23c]

This shows the importance of giving full attention to your opponent's game.

### **Definitions.**

Errors and Faults will be covered in more detail in a future edition of Help!

An **ERROR** is a mistake in play. (See Laws 22 – 28).

A **FAULT** is an error committed during the striking period (see Law 28). There are a lot of these but include such things as “shepherding” a ball through a hoop.
